RELEASE AND INDEMNITY AGREEMENT

Each registrant named on the reverse desires to participate in the tour(s) listed thereon. Therefore, each registrant knowingly and voluntarily WAIVES, RELEASES, SAVES, HOLDS HARMLESS, AND INDEMNIFIES Presidents and Patriots Historical Tours LLC, a Michigan limited liability company (hereinafter referred to as "Presidents & Patriots"), its members, managers, officers, directors, employees, agents, representatives, attorneys, contractors, subcontractors, and other persons or entities acting on its behalf, and their respective successors and assigns (collectively, the "Released Parties"), and all property, assets, and interests owned, leased, operated, or controlled by any of them, from any and all claims, including claims arising from the ordinary negligence of any Released Party, actions, causes of action, demands, rights, damages, costs, losses, liabilities, expenses, compensation, controversies, disputes, obligations, debts, dues, and liens whatsoever, on account of, or in any way arising out of, any and all known or unknown, foreseen or unforeseen loss of life or personal injury, loss or damage to property, and the consequences thereof, directly or indirectly resulting from, incident to, in connection with, or arising out of that registrant's participation in the tour(s) (collectively, "Claims").

Deposit and Cancellation Policy

I/we have read the Deposit and Cancellation Policy, and I/we understand, consent to, and agree to be bound by the conditions and provisions stated in that policy. Cancellations received after the cancellation deadline specified for this tour are subject to forfeiture of the full tour cost, except as otherwise expressly provided in the Deposit and Cancellation Policy.

I/we have read and understand this Release and Indemnity Agreement, which contains the complete agreement between the parties concerning the subject matter of this Release and does not supersede or modify the separate Deposit and Cancellation Policy or other written terms and conditions applicable to the tour.

DISPUTE RESOLUTION

Any controversy, claim, or cause of action arising out of or relating to this Release and Indemnity Agreement or the performance of the tour by the Released Parties, including, without limitation, any claim relating to bodily injury, property damage, or death, shall first be submitted to non-binding mediation in Kent County, Michigan. The parties shall mutually agree upon a mediator, and the costs of mediation shall be shared equally unless otherwise agreed.

If the dispute is not resolved through mediation, any controversy, claim, or cause of action that may lawfully be submitted to arbitration shall, at the election of Presidents & Patriots, be submitted to binding arbitration in Kent County, Michigan. The arbitration shall be conducted pursuant to applicable Michigan law. The arbitrator's decision shall be final and binding upon the parties, and judgment upon the arbitration award may be entered in any court having jurisdiction.

If Presidents & Patriots does not elect to submit the dispute to binding arbitration, or if the particular claim is not legally subject to arbitration, exclusive jurisdiction and venue for resolution of the claim shall be in the state courts located in Kent County, Michigan, or, where federal jurisdiction exists, in the appropriate federal court serving Kent County, Michigan.

Nothing in this Dispute Resolution provision shall waive, limit, or modify any release, waiver, indemnification, or other protection contained elsewhere in this Release and Indemnity Agreement.

Travel Insurance Recommendation - Presidents and Patriots Historical Tours LLC strongly recommends that all tour participants purchase travel insurance to protect their travel investment.
